The Performance Agreement is entered into between the Secretary of Health and Director, Department Of Public Health.

The objectives of this Performance Agreement are:

- a) To establish clarity and consensus about annual priorities for the Department Of Public Health consistent with the 12<sup>th</sup> Five Year Plan of the Ministry, and the Government's other priorities;
- b) To provide an objective and fair basis for evaluating the overall performance of the Department Of Public Health at the end of the financial year;
