3. Degree Certificate and Mark sheet;
4. Class XII Certificate and Mark Sheet;
5. PE Rating for the past two years;
6. No Objection Certificate for applicants from NMS;
7. Valid online approved Security Clearance Certificate;
8. Valid online approved Audit Clearance Certificate; and
9. A copy of a valid Bhutanese Citizenship Identity Card.

Important Note*

1. The selected candidates shall explore and secure admission in recognized Universities and after the admission is confirmed, HRD will facilitate the Training Process with RCSC. Given the limited project timeframe, the preference will be given to those candidates who have already obtained an offer letter/ conditional letter.
2. The payment of the stipend, tuition fee and other associated cost will be processed by the WHO Country Office in consultation with the Pandemic Fund Project Management Unit, DoPH
3. Selected candidates shall be required to take a drug test and will have to pass the test to be eligible for the scholarship
