- The Royal Government of Bhutan has received financing from the Asian Development Bank (ADB) toward the cost of Responsive COVID-19 Vaccines for Recovery Project under the "Asia Pacific Vaccine Access Facility", and it intends to apply part of the proceeds of this financing to payments under the contract named above. Bidding is open to Bidders from eligible source countries of ADB.
- 2. The Implementing Agency (IA), Ministry of Health ("the Purchaser") invites sealed bids from eligible Bidders for "Supply and Delivery" of Mobile Medical Units [MMU] for Hospitals (21 nos.) as per delivery Schedule.
- 3. **Open competitive bidding (OCB): International Advertising** will be conducted in accordance with ADB's **Single-Stage: One-Envelope** procedure and is open to all Bidders from eligible countries as described in the Bidding Document.
- 4. Only eligible Bidders with the following key qualifications defined in the bidding Document may participate in this bidding:
 - a). Successful completion as main supplier within the last 7 years, of at least one contracts each valued at **USD 0.70 million** with nature, and complexity similar to the scope of supply described in Section 6 (Schedule of Supply).
 - b). Submission of audited financial statements or, if not required by the law of the Bidder's country, other financial statements acceptable to the Purchaser, for the last 3 years to demonstrate the current soundness of the Bidder's financial position. As a minimum, the Bidder's net worth for the last year calculated as the difference between total assets and total liabilities should be positive.
