1. Eligibility Criteria

- Should fulfil all eligibility criteria as per Clause 7.7.4 of BCSR 2023, where applicable;
- Should have bachelor's degree at the time of entry into civil service or be selected through BCSE;
- For in-country programs: Probationers are eligible to apply;
- For ex-country programs: Must have completed at least one year of service, including the probation period as on 30 June 2026; and
- Clean service record.

2. System-generated Information

Following information/documents shall be generated from ZEST for shortlisting. Therefore, applicants need to verify the information by logging into the Self-Service Portal, ZEST at <https://zest.rcsc.gov.bt/> within the scholarship application deadline:

- Curriculum Vitae;
- Moderation score/Performance Evaluation Ratings (IWP) for the past two financial years;
- Email address and mobile no.

3. Documents required while applying

- No Objection Certificate from the HRC of Working Agency;
- Copy of Degree Certificate and transcripts; and
- A copy of a valid Bhutanese Citizenship Identity Card.

4. Application procedure and deadline

Interested civil servants under the Ministry of Health who meet the above eligibility criteria must submit the above documents using the following link within **27 April 2026** before 5PM.

5. Shortlisting and Selection procedure

- All the applicants fulfilling the eligibility criteria will be shortlisted;
- Selection Interview will be conducted by Khesar Gyalpo University of Medical Sciences of Bhutan except Dental Programs which will be conducted by the Ministry of Health;
- Selection of candidates will be purely based on merit ranking of the selection result;
- Candidates must seek admission in the reputed medical universities/institutes that are recognized by accreditation bodies or International Accreditation Councils; and
- Candidates will have to secure admission within Regional Asian Countries and commence the course latest by 30 June 2027, failing which the candidature and RGoB Scholarship will be cancelled.

6. Post selection procedure

Upon confirmation of the admission, the selected candidate shall submit the following documents to the HR Division via email at hrd@health.gov.bt, two/three months prior to the course commencement date:

1. Offer letter;
2. Course content;
3. Course fee structure (ex-country);
4. Letter of Good Standing from BQPCA;
5. Valid online approved Security reference no. and date;
6. Valid online approved Audit Clearance for LTT reference no. and date (attach offer letter as evidence document);
7. Valid Medical Fitness Certificate (valid for six months from date of issue); and
8. LTT Study Leave Application Form 7/B available on RCSC website.

7. Important Note

- Selected candidate shall be required to undertake drug test and will have to pass the test to be eligible for the scholarship;
- Only those candidates who are committed to this scholarship should apply;
- In case the selected candidate withdraws from the scholarship due to various reasons after announcement of selection result, the scholarship shall be offered to the standby candidate;
- Selected candidates withdrawing from the scholarship once selected will be required to maintain a cooling period of 2 years to be eligible for study leave for dishonouring the scholarship after signing the Scholarship Acceptance Letter;
- Applications received without the endorsement of the working agency HRC and with incomplete documents will not be accepted for the purpose of shortlisting; and
- The selected candidates upon successful completion of the scholarship will be deployed to health facilities across the country as per the need of the Ministry of Health.
