1. Submission Deadline

Sealed quotations must be submitted to the Ministry on 26th August, 2026 before 10:00 AM.

The bids will be opened on the same day at 10:30 AM in the presence of interested bidders.

2. Route and Airline Requirement

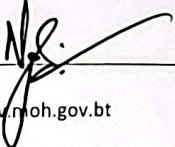
- o Rates shall be quoted strictly as per the specified travel sector.
- o Only the **most direct and economical routes** shall be considered.
- o **Budget airlines are not permitted.**
- o **Layover/transit time** should preferably be a minimum of 3–4 hours for international connecting flights.

3. Itinerary Submission

- o Bidders must clearly indicate the **airline name**.
- o A **confirmed travel itinerary** must be submitted along with the quotation.

4. Fare Commitment

- o Quotations must be **firm and unconditional**.
- o **No increase in fare or change in airline** will be accepted after submission.

5. Seat Confirmation and Validity

- Quoted fares must be valid for the specified travel dates.
- Confirmed seat availability must be ensured at the time of submission.

- A valid Ticketing License issued by the Ministry of Economic Affairs must be submitted.
- A valid Tax Clearance Certificate must also be provided.

"The award shall be made to the lowest evaluated responsive bidder meeting all the requirements."

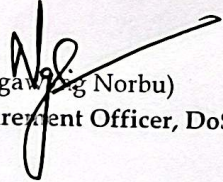
10. Cancellation Clause
